This is for general information of the Public that, the Government of Assam has declared its intent to constitute the land described in the schedule below as Reserve Forest in the name of Gang Dalani Reserve Forest, as per provisions of Section 5 of Assam Forest Regulation Act 1891, vide Notification No. FRM.14/2021/288 dated 6th April 2022.

Further, it is informed that, the Deputy Commissioner, Biswanth is appointed as Forest Settlement Officer for the investigation and determination of claims, and extinguishment of rights in relation to the land within the limits described in the schedule below and the Governor of Assam appoints the Divisional Forest Officer, Sonitpur East Division, Biswanath to assist the Forest Settlement Officer, in the inquiries prescribed Chapter II in connection with the proposed reserve forest.

In view of the above, it is hereby informed to the Public to submit in the prescribed proforma, the claims of any right of any person in or over the land comprised within the limit of the Gang Dalani Reserve Forest, to the Divisional Forest Officer, Sonitpur East Division, Biswanath within three months from the date of issue of this Proclamation. The above mentioned "Claim Form" may be obtained free of cost from the DFO, Sonitpur East Division, Biswanath during office working hours.
