The Governing Body meeting of District e-Governance Society was presided over by **Sri. P. R. Khaund, Deputy Commissioner, Biswanath and Chairman, DeGS, Biswanath.**He welcomed the members present in the meeting and initiated the discussion. The meeting proceeded according to the agenda at Annexure B. The proceedings of the meeting are as follows:

1. **Overview of DeGS:**- The members present were informed about registration of the Society under societies registration act XXI of 1860. The roles and responsibilities and the powers of the Governing Body were also discussed.

DM, DITEC informed that out of 6 (six) Nos of PFC's in the District only 3 (Three) are operating. The Governing Body took decision for making all possible arrangements for the remaining 3 (Three) Nos of PFC's to make it operational ASAP.

- 2. Financial Status:- The ADC, e-Governance gave an overview of the financial status of the society. It was decided to inform the concerned authorities about the deposition of user charges collected by PFC, Gohpur CO & PFC, Halem CO in the saving Bank A/C of DeGS, Biswanath for smooth conduct of the business of the society.
- 3. **Review of eDistrict:**-The Governing Body discussed the different on-going services under eDistrict. It was noticed that the delivery of services are not as per given timelines and in this regard it was proposed to conduct review meeting for eDistrict with all the stakeholders involved with eDistrict online services.

The DM, DITEC informed that at present 9 (Nine) Nos of services are delivered online in Biswanath. It was decided to use eDistrict to deliver Certified Copy of Electoral roll and permission for Fairs/Religious/Cultural Festivals/Loud Speakers/ Rallies/ Strikes services online.

4. **Review of present CSC status**:The DM, CSC-SPV, Sonitpur informed that at present 102 Nos of active CSCs exist in the district. The Governing Body decided to hold a meeting with the VLE's of active CSC's to discuss various issues concerned in providing G2C and G2B services.
