**ORDER**  
U/S/144 Cr. P C

Whereas, the National Green Tribunal, Principal Bench, New Delhi has passed order for compliance in terms of rules 13 of **Plastic Waste Management Rules (PWM Rules)**, 2016, framed under section V of Environment Protection Act, 1986 amended.

Whereas, the Central Pollutions Control Board had issued direction in terms of the said Rules, 13 on implementation of '50um', thickness norms for carry bags manufacturing and closing unregistered Plastic manufacturing and recycling of plastic carry bags and granules as per provision of P.W.M Rules, 2016.

And whereas, many opined there is sufficient ground for proceeding under Section 144 Cr. P.C. for Preventing sells and use of all kinds of plastic carry bags .

Now, therefore, in exercise of the power conferred upon me U/S 144 Cr. P.C. I, Pabitra Ram Khaund, ACS, District Magistrate, Biswanath do here by Order as follows:

(1) No person shall manufacture, stock, distribute, or sell carry bags made of virgin or recycle plastic carry bags & granules, which is less than 50 um (micron).


(2) No person shall be allowed to use any plastic carry bags < 50um. thickness and plastic sachers/pouches usage for packing, storing & selling of gutkha, tobacco and pan masala .

(3) No person shall be allowed to use plastic carry bags, plastic bottles, plastic food container and other such materials in public, religions & historical places as well as in tourist spot of Biswanath District.

Any violation of the order will be invite penal action U/S 144 Cr. P.C. as well as per Environment Protection Act, 1986 as Amended.

This order will come in to force with immediate effect and will continue until further order.


Note: Due to exigencies, this order is given ex-parte. However any aggrieved party/person may approach the competent authority for modification of the order, if any.
